- To monitor our waste streams and seek new opportunities to reduce, reuse and recycle in order to minimise our overall waste arisings as well as residual waste to landfill
- To maximise our use of sustainable card and paper, including recycled content and FSC and PEFC accredited products
- To continue to make use of vegetable based printing ink, significantly reducing the amount of VOCs (Volatile organic compounds) that are released during the printing process.
- To encourage involvement of colleagues at site, through the creation of Local Green Teams

In line with our Environmental Management System we will continually monitor our progress and review our key areas of focus on an annual basis. We regularly review our progress and take remedial action in the event of us falling short of our aims and objectives.
