As we have now completed the first awarding of this qualification, we are pleased to be able to share a wider range of exemplar material for all units created by candidates. We have included a range of disciplines and mark ranges based on work submitted.

Each unit of work will be anonymised and have comments from senior moderators / examiners. These should be used to support with centre standardising prior to assessment of candidates' work. # 10. New Upload Process

To support centres with the upload process, we will be moving to samples being uploaded to **IAMIS** for the internally assessed units **(Units 1 and 2).** This will save time as upload of marks and upload of samples can be completed together within one system without the need to wait 48 hours for a key code (key codes are not necessary on IAMIS). You will also be able to return and upload if something has been missed.

### Instructions

- 1. Navigate to the screen where you input candidate outcomes for each unit entry (<u>Portal</u> > All services > Examinations and Assessment > Internal Assessment/Marks Outcomes).
- 2. On the input screen, where candidate marks have been entered and samples generated, navigate to the far right column titled 'upload' and the cloud icon appears.
- 3. Click the button and upload sample for each sample candidate. IAMIS will accept all standard file formats.

We will be updating our subject specific guidance, in the meantime, there is further information on how to upload to IAMIS on the <u>e-submission</u> page of our website.
