

Thank You Promotion Terms and Conditions

1. Promoter

The promoter of this campaign is WJEC CBAC Ltd, trading as Eduqas, registered in England and Wales (company number 03150875) with its registered office at 245 Western Avenue, Cardiff, CF5 2YX, United Kingdom.

2. Campaign Overview

The Eduqas “Nominate a Teacher” Thank You campaign invites teachers and education professionals to nominate a colleague to receive a thank-you pack in recognition of their contribution to education.

Up to 300 nominated teachers in England will receive a thank-you pack containing:

- a personalised thank-you card
- a message from the nominating colleague
- a complimentary chocolate bar

3. Eligibility

3.1 Nominations must be submitted by individuals aged 18 or over.

3.2 Nominations must relate to a teacher or member of teaching staff working at a school or college in England.

3.3 Employees of WJEC CBAC Ltd (including Eduqas) and their immediate family members are not eligible to nominate or be nominated. Individuals engaged by Eduqas in a non-employed capacity (including examiners) may participate, provided they are not directly involved in the administration or operation of this campaign.

4. How to Nominate

4.1 Nominations must be submitted using the official online nomination form provided by Eduqas.

4.2 Only one nomination per nominator will be accepted.

4.3 Eduqas reserves the right to disregard incomplete, inaccurate or duplicate nominations.

5. Nomination Period

5.1 Nominations will open on Monday 13 April 2026.

5.2 Nominations will close on Friday 29 May 2026, or earlier if 300 valid nominations have been received.

5.3 Once the allocation of 300 packs has been reached, the nomination form may close without notice.

6. Selection and Allocation of Packs

6.1 Thank-you packs will be allocated on a first come, first served basis, based on the time valid nominations are received.

6.2 If fewer than 300 valid nominations are received by the closing date, Eduqas reserves the right to distribute any remaining packs to schools, colleges, or teachers of its choosing.

7. Delivery of Thank-You Packs

7.1 Packs will be sent directly to the nominated teacher at their school or college address.

7.2 Packs are expected to be dispatched and delivered during June 2026.

7.3 Eduqas cannot guarantee specific delivery dates and accepts no responsibility for delays caused by postal or courier services or internal school mail handling.

8. Data Protection

8.1 Personal data submitted as part of the nomination process will be processed by WJEC CBAC Ltd (Eduqas) for the purpose of administering this campaign, including arranging delivery of the thank-you pack.

8.2 Nominators will be asked to provide limited personal information about the nominated teacher, such as their name and school or college address.

8.3 Eduqas will process this information in accordance with its legitimate interests in administering the campaign and recognising teachers.
