# Why choose Level 3 Health and Social Care?

# Unit 3: Explain how services and practitioners meet individual needs

In this optional unit, the aim is for you to understand the work of practitioners, including their main roles, responsibilities and qualifications, and the organisations within which practitioners work, and to carry out research, investigating local views on services. This unit is assessed by a non-examination assessment (NEA)

# Unit 4: Experience of Disease, Illness and Disability

In this optional unit, the aim is for you to: understand the causes, signs, symptoms, diagnostic procedures and treatments of common diseases, illnesses and disabilities; understand safeguarding procedures for both practitioners and service; and to carry out research, investigating local views on services. This unit is assessed by a non-examination assessment (NEA)

### **Unit 5: Human Behaviour and Development**

In this mandatory unit, the aim is for you to evaluate psychological theories of human behaviour and development, and to apply psychological theories, strategies and treatment in a range of care settings. This unit is assessed by a external assessment – an examination
